# 2. Secretary/Treasurer Report Larry Josbeno - See Appendix A

There was a discussion, initiated by Gianfranco Vidali, about our budget. There was a unanimous agreement that we want to preserve the level of commitment to subsidize symposia, (but not at the level of the 2007 Spring Symposia), student support for travel, the newsletter and outreach programs.

To maintain the current level of reserves, and considering that we get about \$11-12 K /year from APS in basic support and interest on uncommitted funds, we could support Symposia at \$2 K each, student outreach \$2 K and outreach grants (\$3-4 K) with the rest for mailing and other expenses, but to be comfortable with this model we need to increase membership, and thus the level of support from APS.

#### 3. Future Symposia

a. Fall 2008 Corning Incorporated will host the Fall 2008 NYSS APS Symposium on 14-15 Nov. The meeting will be held in the Corning Museum of Glass in Corning, NY as part of a celebration of Corning's 100th year of research. The focus of the meeting will be optics and materials science. The topics covered will range from laser physics to advanced materials for industrial microreactors.

The aim of the workshop is to bring together researchers and students from Upstate NY working in condensed matter and materials physics to try to stimulate interactions and new collaborations. The next one will be at RIT on June 6. The attendance has been 70-75 people. Some undergraduates do give presentations at this meeting. So far we have been organizing this on our own funds, but I was wondering if the NYS section of APS may be interested in helping to sponsor this activity. We would of course be happy to write a short proposal with a more detailed description of the goals of the workshop. One idea we have that we may be able to implement with some additional funds is to attach to the workshop a one-day of tutorials for graduate and advanced undergrads focused on some current research topic.

The large shortfall is primarily due to subsidies for the Spring 2007 symposium. Other significant expenses are for student support, the Newsletter and for Outreach grants.

The Section has been committed to increasing outreach (Our Outreach program was lauded, again at the January 2008 APS Convocation). The Newsletter expense is justified because it provides information for our members, and is a recruiting tool for new members. An increased membership will enable us to continue to provide student support and promote physics education.

There are 3971 APS members living in NYS as well as others in surrounding states, so we have the opportunity to grow.

#### APPENDIX C

Report on Fall Meeting 2007 Skidmore College

The Fall meeting of the NYSS APS was a first joint meeting with ASNY. The topic for the 97th topical symposium was Planets: Geophysical and Astrophysical Perspectives on their Structure and Formation. The event was held on October 19 & 20.

There were 108 registered participants, of which 45 were students. 33 of those students were funded by NYS APS for a total of \$1685.

The total cost for the symposium was \$3925. Total income was \$2736. There were additional contributions from ASNY - \$500, and Skidmore - \$250. This gives a combined income of \$3486, leaving a shortfall of \$439 not including student support. If we include that figure, the symposium made \$1246 profit.

The main speaker for the banquet was Robert Zubrin, author of Mars Direct. Funding for Mr. Zubrin was provided by Skidmore's 1st Year Experience, President's office, Dept. of Geosciences and the Dept. of Physics.
