1. Approval of minutes of the Executive Committee Meeting at the 2010 Fall Symposium at Hofstra University:

a. Motion to approve the minutes as amended was put forward by Harold Hastings and seconded by Jim Hannon. It is approved unanimously.

2. Election results and introduction of new members:

a. Gianfranco Vidali reported the results of the election. Sunil Labroo was re-elected Chair and Bodhi Rogers was elected vice-chair. Six members were elected to the Executive Committee as members-at-large: Jay Newman, David Trauernicht, Jill Linz (all re-elected), Scott Heinekamp, Mike Wood, and Harold Hastings. The participation rate to the election was about 11%, in line with rates from other units, but slightly lower than past NYSS elections.

3. Report of the Local Committee – Carl Ventrice:

a. Presently there are 133 registered attendees of which 8 retirees/high-school teachers, and 80 students; 78 banquet tickets were sold and 15 posters were submitted. Hofstra University will contribute with making the facilities available for the Symposium and subsidizing high school teachers' participation. Some of the travel costs incurred by some of the speakers will be paid with a \$1,500 grant from IBM. The main outlays are for coffee breaks, cash bar and banquet. The Symposium is expected to nearly break even.

4. Posters – see Appendix B

a. Reminder of the policy: (PASSED October 15, 2004) the judging committee may award prizes (up to \$600) FOR POSTERS categories at the discretion of the

5. Student support - Bruce White - see Appendix A

- a. 22 students asked support (7 from Freedonia, 1 from Carnegie Mellon, 4 from Binghamton University, 4 from Canisius College, 6 from Oneanta College).
- b. Motion: up to \$100 per requesting student for deferring travel costs to attend the Symposium (see guidelines on the Web for expenses eligible for reimbursement). The student support coordinator has the discretion to reimburse a higher amount/student.

6. Secretary/Treasurer's report - Gianfranco Vidali - see Appendix C

a. Assets with APS as of 1/31/2010 are \$42,164.23. This figure doesn't reflect the money left in the PayPal account (\$3,372.80) from registration for the Fall 2010 Symposium and for the Spring 2011 Symposium.

7. Future Symposia

- a. **Fall 2011** Oneonta College. Topic: Water. It will be held jointly with AAPT (there will be parallel session for teachers).
- b. **Spring 2012** SUNY Binghamton. Topic: Energy

8. Newsletter

a. It was agreed to publish one newsletter a year. No action was taken about setting up an Editorial Board. It was deemed sufficient that the Editor be the one that exercises discretion. A disclaimer appeared in the 2011 issue.

9. Outreach (Jill Linz)

- a. One proposal was received: "Phyzics is Phun," by Allen Miller, Syracuse University, requesting \$1,000; \$750 was awarded and an additional \$250 is awarded contingent to the submission by the applicant of a detailed budget and of more information on whether the signs (the cost of making them is budgeted) will have further use. The motion was moved by Bodhi Rogers and seconded by Jill Linz.
- b. Motion: The acceptance of the award requires the awardee(s)' attendance and presentation of a poster about the supported project at a future symposium within two years of the award. The awardees will still need to submit a written report. Additional financial support to enable the attendance of awardees will be given by the Section.
 - Jill Linz moved and Erika Snow seconded. Motion passed unanimously.

10. Report of the Fall 2010 Symposium (Hofstra University)

As of 1/31/2011 with APS we had a balance of \$42,164.23. This figure doesn't include the liability of \$6,944.94 that was paid to the University of Rochester for expenses incurred in the hosting of the spring 2009 symposium, nor the \$100 for setting up the Website for the Fall 2010 Symposium. However, it includes the expenses for hosting the Spring Symposium at Union College. A year ago, the funds with APS were \$30,625.64. Our financial situation is better this year due to an increase of returns on investments, better control on spending for Symposia, and a decrease in outlays for outreach grants due to fewer proposals submitted.
